Add Premix to the bowl

2. Add water1 & vegetable oil over 1 minute on speed 1 then 4 mins speed 2.

3. Scrape down.

4. Add water 2 and mix for 2 minutes on speed 1.

5. Take SG reading and batter temperature

6. Scale at 1200g into prepared tin and level the surface.

7. Bake at 165°C for 40 minutes (or until baked). Deck Oven 2 top, 2

bottom.
