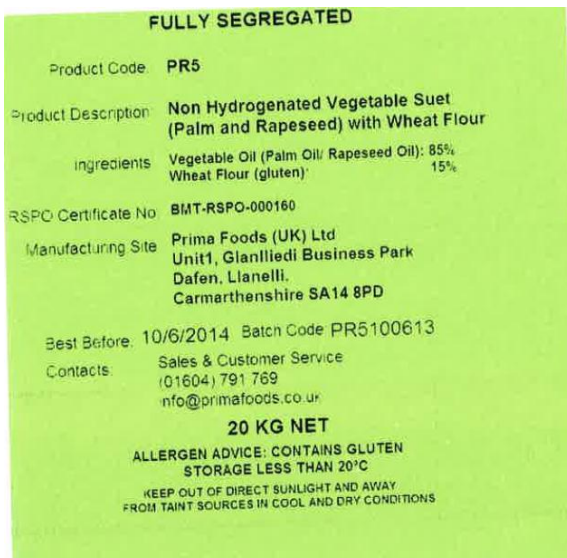

Countries of origin for palm are as follows: Malaysia, Indonesia, Papua New Guinea, with further blending and processing in the UK. The country of origin for Sunflower Oil is UK, Germany, France and for Wheat Flour is from the UK.

COSHH:


